Firstly, H.E SAN SYTHAN, Chairman of the Statistics Coordination Committee, expressed his sincere thanks to all the members for attending the meeting, stating that the purpose of the meeting was to finalize the Sub-Decree on Designated Official Statistics with Ms. **BIRGITTA**, Chief Advisor of Swedish Statistics, sharing her experiences on the development and sturdiness of Swedish Statistics.

On that occasion, His Excellency reported the result of 2008 census to be disseminated and introduced by the National Institute of Statistics in the near future. We will conduct the establishment, enterprise or economic census in accordance with the Law on Statistics. For the agricultural census, we are mobilizing and seeking assistances for the operation in 2010 and the Royal Government has paid much attention, paying nearly 700,000 dollars. We have communicated with the ADB, WB, European Community, and CIDA, pending their responses. ADB is hard because they only have small projects and the agricultural census still lacks nearly 3 million dollars. For the establishment or economic census, JICA will cover both techniques and budget, along with the share of the Royal Government for operation. We have been guided to create a nationwide establishment list, and currently we are entering them into computer system; on this June 9, we will disseminate the temporary result to the users. This economic census will begin in 2011, and currently the Japanese advisors are training our core officials in preparing to implement the tasks at that time.

For the draft Sub-Decree on Designated Official Statistics distributed to the meeting for examination this time, we have also made revision to fit the situation of Cambodia. Thereafter, His Excellency invited Ms. **BIRGITTA**, Swedish advisor, to give comments and share her experiences with the meeting.

Ms. **BIRGITTA**: The Swedish Statistics reformed the responsibilities for the official statistics to a decentralized system in 1994 by creating 24 governmental agents to take responsibilities. The users or clients are able to use good quality statistics to make decisions, implement development projects, allowed to communicate, discuss and give comments on the research to the National Institute of Statistics in widely coordinating the cooperation.

Sweden has a number of legal instruments for enforcing its statistic system, such as the Law on Statistics and the Sub-Decree on Official Statistics etc.

The Swedish Statistics has established a task force with the governmental agents responsible for the designated official statistics to work together as a team or arrange a workshop in case of problems relating to the statistic system.

The official statistics requires several conditions:

- Punctuality
- Quality is a must for official statistics
- A logo needs to be used to identify the official statistics
- Development of template or format for controlling the statistic quality

Every governmental agent responsible for the official statistics requires a website in order to facilitate access to data and task relation.

The National Institute of Statistics, in accordance with the Law on Statistics and regulations in force, shall enforce its duties in cooperating and coordinating the statistics because cooperation and coordination are necessary for enforcing the statistic system, as well as the designated official statistics.

Next, His Excellency the meeting Chair allowed His Excellency **VY HIENG** to report to the meeting on the affairs relating to the Sub-Decree on Designated Official Statistics.

Comments given by His Excellency **VY HIENG** reported to the meeting on some of the following administrative works: during the new parliamentary term from 2008 to 2003, a number of officials have been promoted to department directors or deputy directors-general and this situation affects membership of the Statistics Coordination Committee. Therefore, if you are promoted to higher position than the principles, you are able to request replacement by requesting official letter of appointment of new members from the His Excellency the Minister of the Ministry concerned.

The Sub-Decree on Designated Official Statistics we are now examining is being finalized, therefore you are requested to reexamine; should there be addition or subtraction and it be inappropriate to make decision now, we can raise this case to the management for decision and submit it to the National Institute of Statistics of the Ministry of Planning for entry; after the revision, we will submit it to the Royal Government for approval.

Finally, His Excellency the meeting Chair requested comments from the meeting on the articles in chapter 4 relating to coordination affairs. The meeting generally agreed to the coordination mechanism provided by the Office of Statistics Coordination and Consultation and existing in the new draft.

The meeting concluded at eleven and thirty on the same date.
